



We are glad you have chosen to have a birthday party at Silver Lining Farm!

Enclosed in this packet are waivers that **must be signed by each parent whose children will be participating in the party. Please have these waivers turned in before the party starts. Any child that does not have a waiver signed will **NOT** be able to ride.**

Your birthday party is set for two hours. The children will be able to ride for approximately one hour and fifteen minutes. Usually there is one horse to every 2 to 3 children. After riding, we will take the children on a hayride through the property.

We suggest you bring some drinks such as Capri-Sun, and possibly some snacks along with your cake. We have tables, chairs and tablecloths by the riding ring.

You can also bring treats for the horses! They enjoy carrots, apples, and sugar cubes.

Please advise parents to dress their children in clothes suitable for riding. This includes long pants, boots if possible, and a bicycle helmet if they have one. We will provide helmets for those who do not have their own.

You can include up to fifteen children riders for the price of the party. Each child thereafter will cost \$10 extra per extra child.

Please clean up your trash when you leave. You can either take it with you or give it to us.

No smoking is permitted on the farm.

From Zeigler Boulevard: Go west to Tanner Williams Road. After Snow Road, take next left on Eliza Jordan Road. Go over bridge, and take first right after bridge at Bevis Estates, which is Elnina Drive. Silver Lining is the fourth driveway on the left.

WAIVER OF LIABILITY AND INDEMNITY

I understand that all horse related sports carry the risk of serious physical injury and even death. I accept the fact that if I or any of my children participate in horse related sports, we may be injured, incapacitated, or even killed. I understand that horses are unpredictable and that human beings handling them make errors.

I hereby release and agree to hold harmless any member of the Marybeth C. Peters family, any member of the Davis Pilot family or any of their heirs, and any employee or volunteer of Marybeth Peters, from any and all injury to my child or any member(s) of my family, including me, even if this injury is due to negligence or carelessness on the part of the released persons.

This means if any of us are injured, disabled, or killed in connection with riding the horses at Silver Lining Farm regardless of whether horses are actually involved, I relinquish all legal and financial recourse and agree not to sue any of the released persons. I also agree that in the event any of the released persons are sued on account of an injury to me or a member of my family, I will defend the released persons and hold them harmless from account of all liability and cost claimed on account of such injury.
